PURPOSE and AUTHORITY OF PROPOSED BYLAW:

- Nova Scotia *Municipal Government Act* (MGA) - Sections 172(1)(a), (c) and (d) says councils are authorized to make bylaws for municipal purposes respecting the health, well-being, safety, and protection of persons; persons in public places and places open to the public; and nuisances, including burning, odours, and fumes.
- Nova Scotia *Smoke Free Places Act*, 2002, c. 12, subsection 16(1) reads as follows, "Nothing in this Act affects any other authority to regulate, restrict, or prohibit smoking.

Anyone wishing to inspect or obtain a copy of the proposed *Respecting Smoke Free Public Spaces Bylaw # 28* may do so at the Windsor Town Office, 100 King Street, Windsor, NS between the hours of 8:30am and 4:30pm Monday – Friday, excluding Statutory Holidays, or, it may be viewed on the Town's website homepage at www.town.windsor.ns.ca.
